CAPITAL PARK PROJECTS - THE FOUNDATION LED THE CULLY PARK STEERING COMMITTEE IN COLLABORATION WITH VERDE, THE NONPROFIT LEADING DEVELOPMENT OF THE NEW COMMUNITY-DESIGNED 25-ACRE PARK IN AN HISTORICALLY UNDER-RESOURCED N.E. PORTLAND NEIGHBORHOOD. THE FOUNDATION'S GOAL IS TO HELP RAISE THE FINAL \$500,000 IN PRIVATE GIFTS NEEDED FOR THE FIRST PHASE OF DEVELOPMENT. ADDITIONALLY, THE FOUNDATION FINISHED 2017 WITH ALMOST \$2.7 MILLION SECURED FOR THE FOOTBRIDGE OVER BURNSIDE CAMPAIGN, TO BUILD A SAFE CROSSING BETWEEN FOREST AND WASHINGTON PARKS ON THE WILDWOOD TRAIL. LASTLY, THE FOUNDATION OFFERED FISCAL SPONSORSHIP FOR THE ALBINA VISION, INC., MAKING FUNDS AVAILABLE FOR THE DESIGN AND PROJECT MANAGEMENT OF A PROPOSED DEVELOPMENT CREATING NEW PUBLIC OPEN SPACES IN THE ROSE QUARTER.
